

Course Agreement Global NLP Training

This Course Agreement (the "Agreement") states the terms and conditions that govern the contractual agreement between Global NLP Training having its principal location of business in Amsterdam represented by its owner Nicole M. This agreement applies to the course as a whole:

1. Where hereinafter "course" is indicated, it is in reference to the aforementioned course.
2. The course to which this agreement applies is not in accordance in the requirements set forth to obtain an official diploma recognized by the Dutch government. NLP training under no circumstance can lead to an official university degree, college degree, or high school diploma.
3. All services & support included in the Fact Sheets (Program Option 1: Motivational Coaching.)
4. There are no exemptions available in this course for the participant, obtained through other trainings or certification.

If applicable, Global NLP Training will make it possible for the student to attend the NLP Master Practitioner portion of the course if the student wishes to enter this course after the completion of the course. Global NLP Training can deny permission upon entry to the NLP Master Practitioner program if this request isn't considered reasonable.

Contents and Structure

1. The participant did inform him or herself in terms of the contents and structure of the course and any regulations pertaining to examination (if applicable.)
2. Global NLP Training has structured the course in a fashion in order for each committed participant to complete the course in its entirety during the allocated time.
3. In the event Global NLP Training cancels the course, it will do everything in its power to offer a similar course with another institute or at a different time.

Time and Location

1. Global NLP Training makes the class schedule and locations known to each participant prior to the course start date.
2. Each participant is required to follow the presented class schedule.
3. Global NLP Training reserves the right to change the class schedule or locations for organizational reasons and/or due to the nature of the course.
4. Global NLP Training commits to providing class schedule or location changes timely, prior to the course start time.

Support

Global NLP Training commits to provide appropriate course support.

Cancelation of Course Activities

1. Global NLP Training is required to prevent course activities from being canceled.
2. In the event that a course activity is canceled, Global NLP Training is required to offer this activity at a different time. Scheduling will be coordinated and agreed upon with the participant.
3. Global NLP Training will refund all money paid if for any reason the student is not accepted into the selected program.
4. Instances where a starting class is canceled by the school before the training started or in the event a starting class is canceled by the school, all monies paid will be refunded unless the student wishes to reschedule to a later course date or location. This refund is for school tuition only and does not include expenses paid by the participant for travel, lodging, food or other costs.
5. The school must refund all money paid including the registration fee if the applicant cancels within two weeks after the day initial payment is made, as long as the student has not begun training. After a two-week period, only by exception will restitution be provided if the student has not begun training. A student will be able to reschedule his/her enrollment to another date and/or location without any additional fees. The participant can reschedule a maximum of two times.
6. If training is terminated by the student, after classes have started, and within two (2) days of attendance, the school retains the deposit fee only. In the event the student terminates training after two days of classes, no refund will be given.
7. In the event the training is terminated for the student by Global NLP Training when calculating refunds the official date of a student's termination is the last day of recorded

attendance:

- When the student is terminated for policy or safety violation.
 - When a student, without notice, fails to attend classes for more than 8 hours without prior notice or arrangement.
8. All refunds must be paid within thirty calendar days of the students official termination date.
 9. In the event that a course activity is canceled, the participant will be informed immediately.

Conditions for Course Activity Cancellation:

Global NLP Training aims to execute all planned courses, exceptions will only in circumstances not within our control:

Minimum amount of course participants are not met 45 calendar days before the course start date: 6 (in the event of cancellation due to this reason the student will immediately be notified.)

Due to illness of the trainer

Grave circumstances of the trainer such as death or life threatening emergencies relating only to family members in the first degree (parents & one sibling), and only in two instances in the second degree (1 niece/nephew, 1 step parent)

Flight delays or border patrol circumstances beyond 50 hours of time prior to the course.

Participant Commitment

The participant commits to the best of her or his ability to complete the course successfully within the set time frame. In particular, the participant is required to partake in each course activity, unless there are valid reasons why this participation can not be requested by Global NLP Training.

Costs and Payment

1. In order to participate in the course, costs are associated for the participant: tuition, lodging, coffee service, registration fees, books & materials, and licensing.
2. 3. The costs associated with the course are determined on a yearly basis based on cost and benefit analysis. Global NLP Training aims to keep course fees constant.
4. The costs associated as stated during the online registration process where this Course Agreement has been approved upon. These are outlined under the above mentioned nature of services.
5. A payment plan is available. Please contact us for more information.
6. Registration will only be considered finalized after submission of the course agreement and payment of all course fees or a registration fee.

Cancellation

1. The course agreement goes into immediate effect upon submitting initial payment and agreement to the terms and conditions & course agreement during the online registration and payment process.
2. The participant has two weeks, from the date of signing the course agreement, to cancel the course, without any charge.
3. In the event of cancellation, Global NLP training commits to pay all paid course fees back to the participant within 4 weeks.
4. After a two-week period, only by exception will restitution be provided. This will be discussed between Global NLP Training and the participant.
5. After a two-week period, the participant will be able to reschedule his/her enrollment to another date and/or location. The participant can reschedule a maximum of two times.

Agreement Termination

Termination of this agreement will occur:

1. After the period to which this agreement applies has passed.
2. By completion of the course of Global NLP Training by the participant.
3. In the event the participant has left the course during the assigned time frame of the agreement, and has not responded to a repeated written notice by Global NLP Training. The termination of the agreement does not change the legal requirement for the student to pay all course fees.
4. By mutual approval between the participant and Global NLP Training, after written confirmation by both parties.
5. In the event the participant dies.
6. In the event Global NLP Training is unable to provide the course due to extraordinary circumstances.

Agreement Renewal

In the event that the participant has not been able to complete the course successfully, despite the maximized effort of both parties, both Global NLP Training and the participant may decide that it is in the best interest of the participant to enroll in a different course offered by Global NLP Training at a future date. Should this decision be agreed upon, a new Course Agreement will be put in place to reflect said agreement.

Liability

1. In the event that Global NLP Training is negligent in acting upon the agreement, liability is maximized at the amount of course fees paid by the participant.
2. Global NLP Training is not liable for theft, loss and/or damage of any items owned by the participant during said course, unless Global NLP Training can be found guilty of grave negligence regarding reported items.

Copyright

1. The course program, course structure, manuals, materials and all the intellectual property thereto is solely the property of Global NLP Training. You may not resell, reuse, or share the materials with any other party under any circumstances.
2. Photography, video or audio recording or any other means of recording is strictly prohibited during the training unless previous permission has been granted by Global NLP Training.

Ownership of Course Materials

Global NLP Training will provide as part of this course, the course manuals specified in the corresponding program Fact Sheets (available on our website in the "brochure & fact sheet section".) After completion of the course the ownership of these manuals transfers to the participant. Though copy and reproduction rights as stated above remains with Global NLP Training.

Agreement

This agreement will go into effect immediately upon signing with a cancellation period of two weeks. During this period, the participant will be able to study the agreement and cancel the course unilaterally without being held accountable by Global NLP Training. The cancellation is required to be submitted in writing and is to be directed to a legal representative of Global NLP Training, as mentioned in the first page of this agreement.

Closing Statement

1. In events or situations for which this agreement has no provisions, Global NLP Training will determine the course of action after discussion with the participant.
2. Disputes regarding this agreement can be submitted to a judge.
3. On this agreement, strictly Dutch law (The Netherlands Law) applies.
